SUBJECT: Request Approval for Overnight Trip in Conjunction with Wrestling Masters

Dear Board Members,

1. The Desert Wrestling Team is seeking Board approval for an overnight trip on Thursday the 14<sup>th</sup> and Friday the 15<sup>th</sup> of February to Lemoore, California, the site of the wrestling Masters, hosted by Lemoore High School. The tournament is a three-day event. Wrestling starts on Thursday, and resumes wrestling on Friday and Saturday. The overnight trip allows for coaches and wrestlers to be rested in the event on the second and if needed, the third day. Lemoore is a 3 hour drive each way from Desert Jr/Sr High.
2. The participants, (Justin Cook, Aaron Baker and Kristina Bausler plus one stat girl) will travel in a Muroc Joint Unified School District van driven by Coach Jonathon Kerrill, Coach Bud Maus and/or Coach Bryce Benlian (all approved volunteer coaches).
3. Chaperones: Coach Jonathon Kerrill, Coach Bud Maus and/or Coach Bryce Benlian will serve as designated school site administrators and official chaperones for the trip. Approved volunteer Mike Cook will also chaperone as needed.
4. Lodging: The Team will stay at the Kings Rest Motel in Lemoore, located at 9129 Highway 41, Lemoore, CA. (Phone: 559-924-5681).
5. Meals: Breakfast will be taken after weigh-ins on each day. Lunches will be eaten at the tournament. Dinners will be eaten after the last match on each day.
6. Budget: The trip will require no additional funding from the school or district. The CIF Masters are part of the seasonal schedule. Therefore no additional transportation costs are needed. Each athlete will be responsible for the purchase of their own meals. Meal costs will not be covered by the coaches or chaperones. Lodging fees will be paid by the DHS Wrestling Booster Club.
